- Whose tenders deemed to be interesting and globally acceptable are entitled to recover the amount paid to obtain the specifications. This transaction can only be performed by adding the said amount to the total amount of the offer and this in the event of the signature of the contract of sale.
- Which the offers deemed interesting and globally acceptable will be contacted by email and called for the signature of the contract.
- 3. Each supplier may participate in one or more lots. Suppliers may only participate individually. The choice of supplier will be made by lot, with the exception of lot n° 11 and 13.
- 4. Tenders must be valid for a period of 90 days from the day following the closing date for receipt of tenders.

Evaluation of the technical offer

Evaluation of the financial offer

The evaluation of the financial offer will be exclusively undergone on the on the basis of the offer offering the best quality/price ratio among the regular and compliant tenders fulfilling all the technical conditions required in the specifications or accepted by the company FUN PARK. The bids will be compared with each other by evaluating them from a technical and financial point of view.

### **SITE VISIT**

The bidder is advised to visit and inspect the Site and its surroundings and to obtain on its own responsibility and under its own responsibility all information that may be necessary for the preparation of the Offer. The cost of visiting the site is borne by the Bidder.

The bidder is responsible for inquiring about the condition of the site, the nature of the work to be performed, and the requirements of the contract and its performance. It must carefully examine the plans and sketches communicated by FUN PARK in order to be aware of all the conditions that may affect the execution of the contract. If it detects errors or omissions on the plans, the tenderer must inform FUN PARK immediately so that the latter can make the necessary corrections. By submitting his tender, the tenderer acknowledges having read the specifications and accepts the clauses, charges and conditions.




